



Minutes of the AGM held at 6.00pm on
Monday 16th January 2023
at the Pavilion, Waterhouses

1. Welcome

2. Minutes of the last AGM

3. Matters arising from the minutes

4. Chairman's Report 2022

5. Treasurer's Report 2020/21

Mrs. Pam Coates (PC) issued copies of the accounts for 2022. It was noted that the club had been charged fees from the bank. Discussion took place about changing banks to avoid fees. Treasurer RSt expressed his wish to remain with the same bank, which was accepted by the meeting.

The current balance stood at £1,272.57. Two payments were recorded for completeness where cheques had not yet been cashed or had not yet appeared on the bank statement.

Thanks were given to PC for preparing the accounts.

6. Election of Officers

Officers were asked whether or not they were willing to remain in post for 2023. Chairman RSn had another year to run in post before SM stepped up from Vice-chair. RSt said he would be willing to stand down if someone would be willing to take his place as treasurer. There were no volunteers. GK said he would be willing to continue in as secretary.
